

PRIVACY STATEMENT

Protecting the security and privacy of your personal data is important to YAMAICHI; therefore, we conduct our business in compliance with applicable laws on data privacy protection and data security. We hope the policy outlined below will help you understand what data YAMAICHI may collect, how YAMAICHI uses and safeguards that data and with whom we may share it.

Validity and Responsible Body

This data protection statement is valid for Yamaichi Electronics Deutschland GmbH, Yamaichi Electronics Deutschland Manufacturing GmbH and the online configurator under http://configurator.yamaichi.de.

Responsible body for the handling of personal data is Yamaichi Electronics Deutschalnd GmbH, Bahnhofstr. 20, 85609 Aschheim-Dornach (Germany).

Personal Data

Personal data is acquired on this website only to the technically required extent. Your personal data are only used to manage customers and those generally interested in the company, to provide information about new products, product surveys and for internal marketing tasks in the scope required. Participation for users is voluntary. If you do not wish to take part, you can deregister from these services at any time. You can do this via email to the address stated on the site. We will then block your data for any further use. Our employees are obliged to keep your personal data confidential.

Purpose of Use

When you do provide us with personal data, we usually use it to respond to your inquiry, process your order or provide you access to specific information or offers. Also, to support our customer relationship with you:

- we may store and process personal data and share it with our worldwide affiliates to better understand your business needs and how we can improve our products and services; or
- we (or a third party on our behalf) may use personal data to contact you about a YAMAICHI offer in support of your business needs or to conduct online surveys to understand better our customers' needs.

If you choose not to have your personal data used to support our customer relationship we will respect your choice. We do not sell or otherwise market your personal data to third parties, except to YAMAICHI affiliates.

Purpose Limitation

YAMAICHI will collect, use or disclose personal data supplied by you online only for the purposes disclosed to you, unless the disclosure:

- is a use of the personal data for any additional purpose that is directly related to the original purpose for which the personal data was collected,
- is necessary to prepare, negotiate and perform a contract with you,
- is required by law or the competent governmental or judicial authorities,
- is necessary to establish or preserve a legal claim or defense,
- is necessary to prevent fraud or other illegal activities, such as willful attacks on YAMAICHI information technology systems.



Communications or Utilization Data

Through your use of telecommunications services to access our Web site, your communications data (e.g. Internet protocol address) or utilization data (e.g. information on the beginning, end and extent of each access, and information on the telecommunications services you accessed) are technically generated and could conceivably relate to personal data.
